

I'm sure we will continue to reflect on the impact of the pandemic as we think about our personal, professional, and communal life together. Our Confirmation & High School Youth Ministry Programs are vibrant and growing! We have an amazing team of small group, youth café, and service corps mentors. And on top of all that programming we offered "Our Whole Lives" courses for students in middle school and high school this year.

In the wider Faith Formation community, we welcomed our children, youth and families at our "back to school" orientation in August, our 3rd grade Bible Stepping Stone community combined with our Halloween parade in October, and the Gingerbread House Extravaganza in December.

We celebrated many other transformational faith formation opportunities like the Christmas Pageant and our ongoing thriving Sunday School community. We reinvigorated our acolyte program this year as well! We can see the children's ministry growing as the children gather on the stairs for our Children's Celebration during worship. Our Director of Faith Formation, Kara Holcombe's gifted presence on our staff team has been a bright light for our children, youth and families as we grow in our faith together!

Our Adult Education communities gathered in small groups throughout the year. We focused on the 1619 Project during Lent on Wednesday nights, along with Rev. Valerie Miller-Coleman's class on the cross. Our Supper Circles in the fall were a wonderful success! We had "all church" supper circles, justice and advocacy circles, and Stepping Stone PreK-Kindergarten Supper Circles. We also offered some amazing opportunities during our Fellowship Forums between services Some highlights were the series on "Deconstructing the Roman Road" and our "Reflections on the Book of Revelation".Our Covenant Group ministry continues to make a critical impact as adult small groups grow in faith and friendship.

I have also had the opportunity to re-engage with clergy and colleagues in the Lawrence Interfaith Network, the wider Kansas Oklahoma UCC Conference, and on the Justice Matters Board.

The Mission and Service Board and Open and Affirming Ministry Team supported a position statement on behalf of transgender youth this year. This was hard work. I want to pause and thank each lay leader who helped shape the statement, and the process around it, to make it stronger. We are also connecting more deeply with our mission partner, Kansas Interfaith Action, to amplify our voice as we add our power to other faith communities throughout the state. Head Start is hoping to open a third classroom in the south church this winter, and the PLP classes are back in full swing in our building. Our Open and Affirming Team hosted a Coming Out Day this fall with a fellowship forum and resources to support a loved one who is coming out. The O&A Ministry Team also joined with the Ecumenical Campus Ministries and several other partners in town to support a Trans Day of Remembrance Celebration this November. Our Mission and Service Board had a focus on expressing our gratitude to our hardworking mission partners who have adapted during extraordinary times and our volunteers who serve tirelessly behind the scenes in our direct service ministries like LINK, Family Promise and Just Food.

I want to pause in gratitude to thank our amazing staff team. We support one another and make each other better. It is a true pleasure to work with wonderful people who truly love this church community. Plymouth is a busy and thriving community and our staff team provides the foundation for our growth. I also want to express a warm welcome to Jaron Asher (our new Director of Operations) and Matt Del Vecchio (our Facilities Manager). Jaron and Matt bring a steadiness and specific expertise to our team. This year we blessed Nikki Richardson and Rex Russell as they are embarking on new vocational adventures. They have both given us many gifts that will continue to unfold in the years to come.

It has been a blessing this year to find a sense of "flow" in our work together. I recognize all this work as a "team effort!"



### A FASCINATING JOURNEY

What a fun and odd time to be Moderator of Plymouth. Being Moderator is a fascinating journey through the civic plumbing of Plymouth. So many moving parts and so many ideas.

I had thought at one point that my missive for the Annual Report would be grand, soaring, and inspiring. However, at this point in my Moderator journey, I am hoping for adequate, readable, and finished.

It's not that being Moderator is a bad job. I am extremely honored to have had the opportunity. It's just that spending so much time down in the civic plumbing leaves not so much time for the upper deck with its inspiring views.

The thing about Plymouth right now is that it is working really well. Every member of this church should be proud of what we are collectively doing in a time of division and diminishing faith. Plymouth is truly a beacon of what is so remarkable about Christ's love.

There is far too much misuse of Christianity for division and even hatred. Plymouth is not perfect, but it works daily to be welcoming for everyone, no matter where they are on life's journey. That should not be rare but sadly it feels rare at times.

Every Sunday when I see the swarm of children being introduced to Christ's love in their constant motion, noise, and confusion, I see people being attracted to Plymouth for what we strive to be. Vibrant, sometimes messy, but always moving forward on our faith journeys.

Things like bylaws and facilities are important and I am thrilled with our work in those areas. Yet they are but boring foundations and plumbing for the good stuff happening on top.

Congregationalism and its history of being governed by each congregation can be harder than other options that provide much more clarity and direction. Congregationalism requires more effort than if we were ruled by a mortal power placed between us and God. I am happy that those options exist for those who find that clarity helps them on their journey. However, I am even happier to be in a place where questions are not just allowed but considered part of our faith.

We read our Covenant so often that it becomes rote, almost mechanical. It shouldn't. It is poetry.

Its first line is our mission:

In the love of truth and in the spirit of Jesus, we unite for the worship of God and the service of all.

The rest is how we strive to fulfill that mission and treat one another:

We seek to know the will of God and to walk in God's ways, made known or to be made known to us; to love one another; to proclaim the Gospel to all the world; to work and pray for the progress of knowledge, the promotion of justice, the reign of peace, and the realization of our shared humanity. And we look with faith for the triumph of righteousness and the gift of life eternal. Amen.

Thank you for the opportunity that you have given me. Thank you for keeping it interesting. You're a peculiar bunch but I wouldn't trade you for any other congregation. Life is too short to crawl through it bored.

## CHRISTIAN EDUCATION

### **KOREY KAUL**

2023 CHRISTIAN EDUCATION BOARD CHAIR

The Christian Education Board unites for the worship of God and the service of all by nurturing lifelong faith journeys marked by compassionate and ethical living in a safe, open, and affirming environment. We work to anchor programming in the Bible in its context and in the teachings of Jesus of Nazareth. We strive to orient our faith formation around the Plymouth Covenant and the resources of the United Church of Christ.

Due to the keen leadership and foresight of previous Christian Education Boards, this year has largely involved fine-tuning, continued growth and support of established programs. The Board refined the Safe-Church Policy to utilize inclusive language in line with our Open and Affirming positions. Additionally, under the steady hand of Director of Faith Formation Kara Holcombe, we continue to increase our sustainable volunteer base as the number of families and children continues to grow.

As many people have noticed and commented, there has been a visible increase in the number of young children involved in the Children's Celebration during worship and in Sunday School. With this blessing comes the responsibility to guide these children and allow them to grow in the spirit and fellowship of Plymouth. We are utilizing the Grow curriculum, not only for our children's ministry but for our youth ministry as well.

The CE Board continues to nurture transformational programs like 3rd Grade Bibles as part of our Stepping Stones program. We had a wonderful turnout for Supper Circles during Plymouth Academy, which included our K-1st Grade Stepping Stones Supper Circle. This was an impactful program supporting our families with young children. We have expanded the confirmation classes to a three-year curriculum, and our high school youth explored questions and topics relevant to their lives and how these topics connect to their faith. Every month, our Youth Service Corps program supports the community through service at organizations such as Just Food and The Ballard Center. Additionally, in cooperation with the Deacons, the Christian Education Board re-established the acolytes program after a hiatus of several years. The response and enthusiasm from both the children and the congregation has been a delight. We hosted the popular Gingerbread House Extravaganza for the second year in early December to kick off Advent in collaboration with the Music and Fine Arts Board.

This summer was especially busy as Plymouth hosted Vacation Bible School in our continued collaboration with First Baptist Church and Trinity Lutheran Church. Additionally, the high school group went on a service mission trip to Albuquerque, New Mexico, where they had the opportunity to serve and learn about the local culture and community.

We appreciate the hard work done by so many to nurture the faith of our growing community. Special thanks to Kara Holcombe for her expertise and enthusiasm and Reverend Caroline Lawson Dean for her patient guidance and leadership.





### **DEACONS**

### SUE DENNING AND MATT DEL VECCHIO

2023 ANNUAL REPORT

#### VISION AND GOALS

The vision of the Board of Deacons is to unite for the worship of God and the service of all by serving as spiritual lay leaders of the Church, nurturing the spiritual growth of the Congregation, and supporting the ministry of the Pastors.

#### Goals for 2023 included:

- 1. Develop a "succession plan" so that key leadership roles on the Board of Deacons are filled, and so that effective transitions and continuity of our efforts are maintained.
- 2. Develop a strategy for reasonable and effective use of the acolytes. Coordinate with Christian Education Board to reestablish the use of Acolytes at the Traditional service, and to determine the frequency of Acolyte participation.
- 3. Determine specific roles and responsibilities that belong to the Board of Deacons as determined by Plymouth Bylaws, accepted practices, and in consideration of the work of other Boards and Committees.
- 4. Continue to identify and execute all duties assigned to the Deacons Board in the Plymouth Bylaws.

#### The Board of Deacons:

- Leads, backups, and liaison roles and responsibilities were documented.
- Coordinated with lay leadership and staff to provide materials and support for acolytes.
- Held robust discussions regarding bylaw/policy revisions and requested 12 board members for 2024.
- Continued to refine communion processes.

### IMPACT OF BOARD WORK ON PLYMOUTH AND ITS MEMBERS

The work of the Board of Deacons is intended to nurture the spiritual growth of the congregation and to support the work of the Pastors. Communion provides congregation members and visitors the opportunity to engage in one of the key sacraments of our Christian faith. Monthly devotionals at Board of Deacons meetings provide the opportunity for our own spiritual growth as we take turns providing the devotionals and as we learn from each other. Maundy Thursday and Good Friday services provide opportunities for Congregation members to worship and learn more about the events of Easter week, and Christmas Eve services provide the congregation and numerous community members the opportunity to celebrate together the birth of Christ. The Board of Deacons engages whole-heartedly in the work of nurturing the spiritual growth of our community and our congregation, and in supporting the work of our Pastors.



### FELLOWSHIP BOARD

### **HIGHLIGHTS FROM 2023**

### COFFEE HOUR • Tom Ladehoff, chair

We have been fortunate to work with Hospitality Associates, Gene Tyner and Jane Walters, in offering a Fellowship Hour every Sunday between services in the Mayflower Room. The Hospitality Associates are responsible for managing coffee hour plus set up and clean up. One board member volunteers to assist every Sunday working from 9:15 to 11:45 helping with whatever is needed to help the Associates.

Rev. Valerie mentioned to some of the board members that she would love to have the aroma of home-baked cookies wafting through the entries. So we decided to start baking cookies with dough bought from the grocery store. Later, Tom decided to order cookie dough from Costco. Since we have been doing this, attendance at Fellowship Hour has exploded which has created a deficit in our coffee budget. We also changed our coffee purchases from ground Folgers to J&S coffee beans, regular and decaf. This has also increased our spending for coffee hour.

### ESTHER'S COOKIE BAKERS • Ann McElhenny, chair

Ann resurrected this tradition. She has a list of volunteers who have been happy to supply cookies by the dozen for specific Sundays, such as Mother's Day and the Fourth of July. These supplement the home-baked cookies provided by the Hospitality Associates and are greatly appreciated by the congregation.

#### THE PRIDE PARTY • Nancy Bregman, chair

This was the third year for this event. Nancy worked very hard to have everything organized and ready, but the weather interrupted activities with rain and cool temperatures. Nancy felt that this put a big damper on the number of people attending and partaking in the games, rainbow sherbet, and music. Because of the weather we had more than 15 gallons of sherbet left which was stored in the kitchen freezer. This is a very worthy event that we share with the Open and Affirming Committee and will continue our commitment.

### THE ALL-CHURCH PICNIC • Linda Thompson, chair; Linda Mannering, vice-chair

Linda Mannering worked with the church staff to get advance advertising. She also organized the sign-up sheets for church members to bring sides and desserts. Linda Thompson organized the purchase of meat, buns, and condiments. She worked with the Facility Manager for ordering food and supplies. Everyone on the board took on jobs for the day, and we had a beautiful day of food, fun, and visiting. In addition to the desserts brought by members, we gave out the leftover rainbow sherbet from The Pride Party.

### THANKSGIVING DINNER • Julie Bach, chair; Ann McElhenny, vice-chair

Because of Julie's exceptional leadership and organization skills, this year's event ran like a well-oiled machine!! Every board member fulfilled their specific duties and the volunteers provided extra hands as needed.

The side-dishes and pies provided by the church members were delicious. The catered food from Hy-Vee arrived on time this year with hot turkey, gravy, buns and butter. Again, this year we had food left over so that LINK could use it for their Thanksgiving meals.

We are so thankful to Matt Del Vecchio and Gene Tyner for getting all the tables and chairs set up before Friday so that the board members, upon arriving to set up and decorate, were totally shocked and grateful to see this work already done.

This event is our biggest of the year and we are so thankful for everyone on staff and church members who contribute to its success.

### MEMBERSHIP BOARD

### **KELLEY STILLINGS**

2023 MEMBERSHIP BOARD CHAIR

The Membership Board had another good year in 2023. We welcomed 62 new members this year! They were an impressive group of people from different backgrounds, age groups, and various stages of family life. Plymouth is blessed with their presence. We know they will bring much life and faith to our community.

We continue to believe that welcoming new people in the church is one of our most important roles.

Here is some of what we do:

- Each Sunday morning, we staff the Welcome Table, stationed just outside the sanctuary doors – we strive to be a welcoming presence to folks visiting the church.
- Once per month, we hosted Discover Plymouth. A time on Sunday between services for visitors to meet other new people, meet the pastors and ask any questions they have about Plymouth.
- Three times this year we hosted a New Member Orientation Sunday followed by a Join Sunday a few weeks later.

• We planned and hosted a new event this year for our new members - a potluck dinner. Scott and Kathleen Morgan graciously opened their home. The weather was perfect, and we had quite a large group of new members and Membership Board members in attendance. It was a lovely evening.

The Membership Committee sees care of our members as a vital part of what we do.

- We honored our 50-year members this year at the Harvest Home Dinner with new gold nametags!
- Our board coordinated the Meal Train, which served 75 meals in 2023!
- We started a Flower Ministry. This ministry breaks down the large floral arrangements from the Sunday services into smaller arrangements. The flowers are delivered to members at their home. We have delivered approximately 60 flower arrangements since the start of this ministry in July 2023.
- We initiated a new Caring Ministry, designed to support people in our congregation living in nursing homes, retirement communities or who are homebound. Twelve "Caring Ministers" were trained at a series of Listening Workshops led by Rev Marc Giedinghagen and Rev Heather Coates, and then blessed at a Sunday worship. Today, several of them are regularly visiting people in our congregation.
- In October, Plymouth Member, Rachel Monger, President & CEO of LeadingKansas, a non-profit that works for aging people in Kansas, taught a five-part series called, The Art of Aging, designed to help people navigate the landscape of issues around aging. It was attended by about 15 members and was very informative.
- In November/December, the Revs Heather Coates and Marc Giedinghagen offered a five-week Grief Support Group.

- During Lent & Advent, partnering with the Plymouth Mental Health Committee, we offered days of silence, meditation and coffee at the church. In Advent, we included a labyrinth walk to the day. This addition proved popular.
- Our final offering of the year, on the Monday before Christmas, we hosted a Longest Night Service. This is a service for anyone who is struggling during the holiday season. Members of the Board read scripture and lit candles during the service. It was well attended.

A note from Heather: We would like to thank Kelley Stillings for her leadership! She has served faithfully as the Board Chair of Membership for two years, and is finishing her service on the Board this year. Under her leadership, the Membership Board has grown and flourished. Thank you, Kelley, for all that you have done.

## MISSION & SERVICE BOARD

### **BRANDY ERNZEN**

2023 MISSION AND SERVICE BOARD CHAIR

2023 was a year of transition for many of Plymouth's mission partners. For instance, Head Start closed its classrooms early in the spring due to staffing issues, but reopened this fall with a new director. Family Promise rebooted its signature congregational rotation option for families needing shelter, but pivoted to a temporary sheltering program in the fall. Plymouth Language Program welcomed in-person classes for the first time since the pandemic. Justice Matters welcomed a new lead organizer just weeks ago.

These changes affected our priorities this year. To recognize the important work both our mission partners and our congregational volunteers do for our community, the Mission & Service Board focused on showing gratitude. Churchgoers signed oversized thank-you cards to our mission partners that we delivered along with treats at Thanksgiving. We also sent handwritten thank-you notes to many of our volunteers throughout the year.

The MSB also hosted a volunteer fair in August to raise awareness of ways to get involved at Plymouth. Attendees met with lay leaders from more than 30 mission and service, music and fine arts, fellowship, membership, and care ministries.

Some of the highlights that Plymouth members made possible include

- The Church Council passed the Open and Affirming position statement supporting trans youth!
- The Racial Justice, Opening and Affirming, Earth Care, and Plymouth Immigrant and Refugee Alliance teams joined forces to create a single Social Justice Team. Thanks to all who are helping shape the direction of our upcoming justice work!
- We began crafting volunteer job descriptions for LINK and other ministries to outline expectations of different positions and to help recruit leadership for our regular mission work.
- The Easter offering raised \$4,000 for the Plymouth Language Program, \$1,718.74 for Head Start, and \$1,718 for UCC's disaster relief fund for Syria and Turkey earthquake victims.
- The Head Start backpack and supply drive resulted in 20 filled backpacks for incoming kindergarteners, supplies donated to the Kennedy Early Childhood location, and almost \$800 donated to Plymouth's Head Start program to be used for playground upgrades and \$500 for their general fund.
- We provided hot and frozen meals, snacks, and grocery gift cards for three 1-week Family Promise rotations.
- We provided hot lunches once a month for LINK.
- We donated \$2,500 to the Lawrence Community Shelter for operating expenses.

#### Christmas Mission Drives:

- Head Start Angel Tree provided clothing and toys for more than 36 Head Start preschoolers.
- Willow Domestic Violence Center drive raised \$405 in gift cards, plus toiletries and diapers.
- Lawrence Community Shelter drive provided \$310 in gift cards, as well as new socks and toiletries.

Christmas Eve offerings raised \$3,253.33 for Justice Matters and \$3,253.33 for Our Church's Wider Mission (OCWM).

2023 MUSIC AND FINE ARTS BOARD CHAIR



- Prayer Shawl Ministry
- Support ongoing repair and maintenance of sanctuary organ, bells, and pianos

Carrying out these activities requires many hands. While we do not have an exact count of all the volunteers who made these efforts possible, we estimate that 384 people contributed their time, talent, and work to these accomplishments. Their work included practicing, performing, setting up facilities and venues, providing food, serving food, leading classes, cleaning up, and meeting each month to plan the work of the Board. Through that work, friendships sprouted, and old friendships grew stronger.

This year saw the official end of the pandemic and the beginning of a new normal. One of the goals of the MFA Board was to help draw people back together after normal patterns were disrupted. MFA activities and events drew people in as both participants and organizers. We estimate that 637 people attended classes and special events. In addition, the entire congregation benefited from music and performing arts presentations during worship and special services. These music and fine arts events contributed to the goal of welcoming all through Plymouth's doors and helping them find their unique ways to worship and serve God.





### STEWARDSHIP BOARD

### **DEBBIE SCHMIDT**

2023 STEWARDSHIP BOARD CHAIR

Stewardship is defined as the careful and responsible management of something entrusted to one's care. The Stewardship Board, along with the Treasurer, Deputy Treasurer, and very proficient church staff, worked hard to be financially responsible managers of the 2023 budget. At the 2023 annual meeting, the congregation passed a deficit budget of -\$42,572. Due to the generosity of our congregants, we finished 2023 in a positive financial position without utilizing our reserves or savings from the Payroll Protection Plan. The 2023 net surplus was \$24,926!

#### Goals for 2023:

- Produce a balanced budget for 2023 (Congregational approval received for a deficit of \$42,572 in the MSP).
- Support increased funding in the MSP with attention paid to cost of living increases for staff, support of other Boards' requirements, and stewardship education.
- Articulate the connection between the Church's facility and its mission in annual appeal materials and communications.
- Support the practice of giving to local missions as prioritized by the Mission & Service Board.
- Review the financial report and make necessary adjustments to procedures as suggested by the auditing firm Forvis.
- Determine priorities in the Master Facilities Plan.
- Study the addition of solar energy.
- Adjust to any changes made in the Plymouth bylaws.

### Highlights of 2023 include:

- Received the final financial and operational assessment report from financial auditing firm Forvis and verified that accounting/operational procedures are in alignment with the findings.
- Began research on hearing assist options for the sanctuary – no final decision at this time pending future enhancements to the sanctuary.
- Financial education through class offerings (Pastor Valerie taught Theology of Money)
- Approved cash management procedures to ensure that deposited funds are covered by FDIC regulations and invested funds receive the best possible interest rate.
- Directed the facilities committee to explore solar options for the south and north roofs. This included financing solar use through tax credits, a Rice Foundation grant, and an anonymous donor. An application was submitted to the City of Lawrence Historical Resources Commission for approval to be determined at their January meeting.
- Approved Phase I facility improvements within the 2023 budget to include masonry work and new paint in various areas of the Church. An upgrade to the audio-visual facilities in the Mayflower room is planned for 2024.
- Recommended Church Council approval for services provided by Generis Partners, LLC for the purpose of exploring a potential capital campaign (upon congregational approval) for the refurbishment of the organ and sanctuary renovation.

Plymouth's future is bright as we unite for the worship of God and service for all. We recognize that continued financial stewardship is paramount in 2024 and beyond as we navigate challenges that occur with generational changes within our congregation. The good news is that we have strong leadership with our pastors, church staff, lay leaders with a committed and generous congregation.



### **FACILITIES**

### **DOUG EASON** 2023 FACILITIES BOARD CHAIR



The Facilities committee accomplished one big project in 2023. We invested \$47,000 in maintaining the masonry work of the historic church. Most of the work was to repair the sandstone capstones. We also had some brickwork replaced. This work involved blocking off several parking spots in front of the church for several months.

The Facilities Master plan was also broken down into 3 phases. Phase 1 is to address many public space needs that have been deferred for a while like replacing carpet and refreshing paint. Included in Phase 1 was to investigate the installation of solar panels given the tax credits now available. Phase 2 will address the organ and accessibility issues in the sanctuary. Additionally, this phase would investigate using the basement for more than just storage and changing the flow into the North church. Phase 3 would be to relocate the church offices to the south side in a new space and to build a new choir room above it. This would allow for a more welcoming space on the 1st floor North building.

Phase 1 work has started. Painting began on Dec 26th on the public spaces on the first floor in the North church. Bids for solar panels have been obtained. We have an application into the city to approve putting panels on the South church. It will be heard on January 18, 2024. Once the approval is secured, we will work to get Council approval for the project. We also have been narrowing down choices for carpet in the Mayflower room and Narthex. Expect to see these improvements in 2024.

We want to thank Rex Russell for his nearly 9 years of service as our facilities manager. He made significant improvements in many aspects of our facilities to include getting a firm handle on our HVAC systems, lighting, and security. We welcomed Matt Del Vecchio in May to replace Rex. He has jumped in and been able to use his gifts to continue to move our facilities forward.



### **HISTORY**

### **SUSAN MCCARTHY**

PLYMOUTH HISTORIAN

One of the goals of our committee for the past year was to lay the groundwork for installing a plaque outside the Head Start room where President Barack Obama visited in 2015. That visit was a historic occasion for this church. Never before has a sitting president visited Plymouth Church. In fact, there have been only five other occasions in the entire history of Lawrence, Kansas when a sitting president visited the city. To have President Obama come to our church is worthy of remembrance. The reason for his visit was to pay tribute to the early childhood education program, Head Start, housed at Plymouth. Head Start has been a central core of our church's mission since 1966. The plaque will be installed in early 2024.

As part of our outreach to the congregation to teach or remind members about aspects of our history, we have put up several bulletin board displays. (The History Committee bulletin board is opposite the office suite or outside the Mayflower Room.) One was about the annual Plant Sales which were a huge endeavor from 1992 to 2019 and involved many members. These sales contributed large sums of money to the budget. The plant sales have now been supplanted by other fund raising efforts such as the garage sale and currently, the auction.

Another bulletin board brings back memories of an important Redbook magazine article, published in 1982. The article featured holiday scenes at Plymouth from that year, focused on our traditions and showed off the beauty of our sanctuary.

One of our members has been involved this past year in the Oak Hill Cemetery project to care for the gravestones of former Plymouth members. The Cordley Memorial is of particular interest and has been cleaned, although minor work remains to be done to the marker. Members continue to contribute articles to the Rock on occasion. We have upcoming selections on several past ministers coming this next year as well as more entertaining bulletin board displays planned. As always, we continue to keep our records in shape and file historic documents.



### BYLAWS TASK FORCE

### **SCOTT MORGAN**

2023 PLYMOUTH MODERATOR

The rewriting of our Constitution and Bylaws as well as the creation of a new Policy Book was a tremendous effort that culminated in the adoption of the Constitution and Bylaws at a called meeting on September 10th. The Policy Book was adopted by Council at its December meeting.

The Bylaws had not had a thorough, starting-from-scratch review since 1988. A several year review of Plymouth operations done by the Plymouth Continuity and Operations Planning (or PCOP) Committee had found the need for more clarity in the roles and responsibilities of the various boards, committees, and staff.

Council decided in December of 2021 to create a Bylaws Task Force to review the governing documents of Plymouth and recommend changes that the Task Force thought appropriate. That Task Force began in earnest in February of 2022. It spent a year reviewing, discussing, writing, and rewriting.

The Task Force presented its drafts to Council at its February 2023 meeting. Council spent the next three meetings going through the Constitution and Bylaws line-by-line. At the same time, sessions were held with the congregation between services to seek feedback and answer questions. A number of changes were made by Council in response to the feedback. At its May meeting Council approved drafts to send to the congregation for its consideration at a called meeting. It was decided to wait until after the summer to hold the meeting so the date was set for September 10th.

While maintaining the congregation as the ultimate governing authority, changes include:

- 1. Reducing Council from 17 or 18 voting members to 10 members all directly elected by the congregation. Also, reducing Council turnover each year from more than 50% to 33%.
- 2. Blending Council and Stewardship into one true governing body with the duties and fiduciary responsibilities of trustees, combining the oversight of the church program and the secular functions.
- 3. Providing a clearer goal setting and strategy process.
- 4. Clarifying the remaining boards' roles in implementing Plymouth's ministries.
- 5. Ensuring diversity of perspectives in nominations.
- 6. Developing a policy process that moves many details from Bylaws to flexible, Council-controlled policy. All such policies require authority from language in the Bylaws.
- 7. Strengthening Council's capabilities by enlarging the number of Council committees.
- 8. Renewing Council's planning and coordinating role by creating quarterly joint meetings of Council, board representatives, and staff.

At the September called meeting the Constitution was approved by 68% of the voting members. The Bylaws were approved by 61% of the voting members. As with all major changes, there were differing opinions and strongly-held views. However, the extensive process and deliberation reflects the strength and vigor of our congregation-led governance.

### MINUTES FROM THE 2023 ANNUAL MEETING

168<sup>th</sup> Annual Congregational Meeting
Plymouth Congregational Church, United Church of Christ
Annual Meeting Minutes
Sunday, February 5, 2023

#### Call to Order – Devon Kim, Moderator

Devon called the meeting to order at 10:58 am.

- 1.1 She appointed Clay Britton parliamentarian. Clay stated a quorum was present as 115 members were in attendance and 98 was the minimum required.
- 1.2 Approval of Agenda Devon Kim
  <u>Scott Morgan moved to approve the agenda as presented; David Ambler seconded; motion passed unanimously.</u>

#### 2. Invocation – Rev. Dr. Valerie Miller-Coleman, Senior Pastor

Rev. Dr. Valerie Miller-Coleman led the congregation in prayer.

#### 3. Approval of Minutes of the Feb. 6, 2022 Annual Meeting – Devon Kim

Doni Mooberry Slough moved to approve the minutes as presented; Doug Eason seconded.

#### Discussion

David Bergeron expressed his confusion regarding the blank space on page 33 and asked if it was part of the minutes. Devon Kim said the minutes were printed on pages 34-36 and the blank space was probably due to formatting. David believed the word "committed" found in the 2<sup>nd</sup> and 4<sup>th</sup> paragraphs on page 35 should be "commented". He also said he was the only individual whose last name wasn't provided in the minutes.

With those amendments, the motion passed unanimously.

#### 4. Recognition of Boards, Officers and Committees – Devon Kim

Devon expressed her appreciation for the work of board chairs and members during the past year. She also offered an apology to Paula Pepin for not properly listing her as the chair of Music & Fine Arts in the annual report.

Following a comment regarding voting procedures, Clay Britton said it was considered best practice to have members vote "yea" or "nay", followed by an opportunity for discussion before calling the question.

Devon then thanked Derrick Hurst for his three years of service on the moderator team, saying he was a true renaissance man as he took on additional family responsibilities during that time.

#### 5. Presentation and Approval of the 2022 Financial Report – Doni Mooberry Slough, Treasurer

Doni thanked the congregation for the opportunity she and Rich Bireta were given to serve as Treasurer and Deputy Treasurer. She also expressed gratitude for the work of Melissa Praderio and Nikki Richardson, Plymouth's staff accountant and operations manager; for the Senior Pastor's participation in Plymouth financial activities; to Doug Eason and the Stewardship Board and to Stephen Carttar, who continued to provide accounting and fiscal guidance.

Plymouth depends upon contributions of time, talent and treasure. Because of committed congregational support, financial resources were strong in 2022. Coupled with responsible spending, the year ended with

a modest surplus of \$14,985.37. Pledged income was 5.15% higher than anticipated, with a large portion attributable to giving over and above 2022 pledges.

The 2023 annual appeal exceeded expectations. Doni expressed confidence that the five-year plan developed and discussed at congregational meetings in October, December and January will allow Plymouth to continue to build financial strength and sustainability.

Plymouth's year-end operating reserve was \$293,169.43 and savings resulting from the Payroll Protection Plan (PPP) were \$96,900. The 2023 Mission Spending Plan (MSP) reflects an operating deficit of \$40,376, a portion of which is a \$20,000 transfer to the operating reserve. Doni and Rich feel diligence in setting aside money annually for unexpected expenses is a prudent fiscal practice and should be continued. However, in 2023 the \$20,000 will "move" into the reserve and immediately "move" back to cover expenses, leaving a projected cash deficit of \$20,376 which will be covered by PPP savings.

Doni Mooberry Slough then moved to accept the 2022 financials as printed in the annual report. Geraldo Sousa seconded.

#### Discussion

Geraldo Sousa thanked Doni Mooberry Slough, Rich Bireta, Doug Eason and members of Stewardship for their exemplary service to the church.

There being no further discussion, the motion was unanimously approved.

#### 6. Approval of the 2023 Budget – Doug Eason, Stewardship Board Chair

Doug Eason referenced the proposed MSP found on pages 51-54. He said that Stewardship is historically conservative relative to managing income and expense and added that income is based on actual pledge cards received. On the expense side, it was important to fund all requests, including an 8 1/2% COLA increase for staff. The Communications Director position is fully budgeted, in the event the current process for handling those responsibilities changes. He reiterated that the \$20,376 net deficit will be covered by PPP funds. Because of various opportunities for income and expense adjustments in 2023, both Stewardship and Council are comfortable recommending a deficit budget for approval.

Doug Eason moved to adopt the 2023 MSP presented on pages 51-54. Annas Boyer seconded.

#### Discussion

Geraldo Sousa asked if the housing allowance budgeted for pastoral staff can be extended to other staff. Doni Mooberry Slough said the IRS code only permits the allowance for ordained ministers.

There being no further discussion, the motion passed unanimously.

#### 7. Nominating Committee Report and Election of Officers – Scott Morgan, Chair

Scott Morgan thanked Heather Coates and the boards for their work on the nominating committee. He explained that the congregation is only voting on individuals whose names are followed by an asterisk. The names followed by a cross are appointed by Council.

Scott Morgan moved to approve the slate of nominees. Steve Bradt seconded.

#### Discussion

Elinor Schroeder noted that the treasurer position serves a one-year term for a maximum of six and should be voted on (an asterisk added). Scott Morgan said that was correct.

#### With that correction, the motion carried, with one abstention.

Scott Morgan then asked Sonia Jordan, the moderator-elect to come forward and introduced her to the congregation. She and her husband James have three children and have been members of Plymouth for 7-8 years. She is an employee of the Douglas County Health Department and had an instrumental role in the community's pandemic response. Scott welcomed her to the Moderator Team.

### 8. Open Forum – All

Devon Kim explained the open forum is an opportunity for members to express thoughts regarding Plymouth programs, plans or policies.

David Bergeron requested information from the Personnel Chair regarding the Sr. Pastor review, found on page 45. Ruth DeWitt, Personnel Chair, said the review process was changed in 2020, pursuant to a policy revision approved by Council.

All staff, including the Sr. Pastor, now have job descriptions, metrics, core competencies and goals upon which performance is gauged. Instead of calling for general feedback from the congregation, the chair requested and gathered feedback from various segments of the congregation. The intent was to obtain diverse, constructive and robust feedback from individuals who work with the Sr. Pastor.

Thirty-two representatives from various church sectors including Council, new and old board chairs, new members, adult members, staff, second service attendees, adult education programs, Deacons, Music & Fine Arts and Justice Matters were asked to respond to a performance matrix. Twenty-three responses were received (71%).

David was most concerned that the process seemed to be in violation of the bylaws which state that broad congregational comment be gathered annually. He agreed with the efficiency and effectiveness of the process, but in his opinion 23 responses was not broad. He felt broad meant the 995 members of the congregation. Ruth said her definition of broad was a representation of the "pillars" of Plymouth. David asked why not do both – garner segment and general feedback.

Scott Morgan said the current policy was voted on by Council and he believes it adheres to the bylaws. He added that members are welcome to bring concerns and comments regarding the policy to Council for their consideration. We do need broad feedback throughout the year, but in this instance we're following the policy.

Harold Riehm said he wasn't aware of any solicitation for input regarding the Sr. Pastor. Devon said there wasn't a formal process for the Sr. Pastor review until 2020. Prior to that time, a call for general feedback was used for the evaluation.

Devon said in many Council meetings she offered the opportunity to meet with members at any time and asked the Clerk to note it in the minutes, as another venue to receive feedback. She reiterated the moderator team is open to feedback regarding Plymouth at any time and can do so via email, phone call or in person.

Sue Denning clarified she was not the chair of Deacons (page 13); it was Marcia Powers and she deserves credit for her work.

Geraldo Sousa requested more transparency and communications from senior lay leadership. He would like to see monthly reports of accomplishments and challenges from the Moderator in The Rock. Council minutes from two fall meetings weren't communicated at all. There is some exemplary service in the church, but the moderators should be held to a higher standard. He then asked to remember Phil Friedeman, who always held our feet to the fire especially regarding mission and stewardship.

Devon responded that her interpretation of the Moderator's role was like that of a board chair – to set agendas, moderate Council meetings and ensure that the work of the church was accomplished. She felt that what she would share would be duplicative of what staff had already provided. She thanked Geraldo for his comments and suggested they meet at a later time to further discuss his concerns.

Irene Soderstrom said the Moderator is a volunteer position which requires an unbelievable amount of time and although she likes to read reports, they take time and energy to produce. She felt an element of grace should be extended to those in volunteer positions.

Harold Riehm asked about the advocacy process on page 34. What is the status – was a report made – is there action pending? Devon said the Advocacy Process Discernment Policy was approved by Council in May 2022 and the minutes were shared shortly thereafter. She explained the policy provides a process for issues to come to Council for discernment and said she will send the policy to Harold.

Gene Tyner referenced service changes due to the pandemic. The change for serving communion is working well, but he wondered if it would be possible to return to a time at the beginning of the service to greet one another. He misses that small part of the service.

Max and Jeanne Fridell wanted to thank Valerie, Caroline and Kim for their commitment, dedication and caring.

Bill Kraybill thanked Valerie and Caroline for their service to him and his family following the loss of his wife, Judy. He is so appreciative of the ministry and members of the church.

Susan McCarthy echoed Geraldo's comments about Phil Friedeman. David Trevino shared some comments from the time he and his wife, Sarah Whitten, spent with Phil while he was in ICU. He loved Plymouth; appreciated the leadership and pastors; read the annual report cover to cover and had a passion for OWCM. He was also writing a letter to President Putin regarding Ukraine and expected a response. Valerie confirmed a receipt certifying delivery of the letter had arrived from the Kremlin. Sarah suggested consideration be given in the future to a special OWCM offering in Phil's memory.

Rev. Dr. Valerie Miller-Coleman thanked Devon for her service – she served faithfully and was the leader needed in a difficult year.

#### 9. Presentation of the 2023 Moderator – Devon Kim

Devon introduced Scott Morgan as 2023 Moderator and presented him with the Moderator's cross, brought back into circulation in 2021 by Diane Sanders, and church gavel.

#### 10. Response – Scott Morgan, 2023 Moderator

Scott said he had learned so much from Devon and looks forward to continuing to work with her. He then announced that a contribution in her name has been made to Heartland Community Health Center, an organization that is very meaningful to her.

He thanked the congregation for the honor of being elected Moderator. He said balance is now restored in the Morgan home, as his wife, Kathleen is a past moderator and used to describe her role as a "kind of the Pope" of Plymouth to her large Catholic family. He's excited to be the new "kind of Pope".

Scott said Plymouth is a strong and vibrant church that welcomes all wherever they are on life's journey. We require allegiance to no religious creed or political dogma. Rather we enter a relationship based on a covenant, a covenant seeking the will of God and giving grace to all. We are far from perfect and need foundational work, but our spirit is invigorating. And everything happens because people care.

#### 11. Adjournment – Scott Morgan

Devon Kim moved to adjourn the meeting; Derrick Hurst seconded. Motion carried unanimously. Meeting adjourned at 11:58 am.

# MINUTES FROM THE SEPTEMBER 10, 2023 CALLED MEETING

Called Congregational Meeting of Plymouth Church September 10, 2023

Prior to the Call to Order, Clay Britton, the meeting parliamentarian, stated a quorum was present as 125 members were in attendance and 100 was the minimum required.

- 1. Scott Morgan, Moderator, called the meeting to order at 10:42.
- Reverend Valerie Miller-Coleman gave the convocation.
- Approval of Agenda and proposed meeting rules.

Scott provided the proposed meeting guidelines and rules:

- Ballots will be distributed once a motion has been made.
- b) Members may vote once they receive a ballot, but all are encouraged to listen to comments.
- c) There will be a 10-minutes introduction by the Bylaws Task Force.
- d) There will then be a period of no more than 20 minutes or until 11:10 (whichever comes first), for members to speak once each for no more than 2 minutes. To maximize the number of members who can speak, questions and comments will not be addressed by Council or the task force.
- e) We will recess by 11:10 to the Mayflower Room in time to allow the Gathering of Grace service at 11:30.
- f) All who are interested may move to the Mayflower Room and wait for the votes to be counted. The results will be announced in the Mayflower Room.
- g) The meeting will be adjourned after the results are announced.
- h) If the congregation does not approve these proposed meeting rules, the meeting will recess at 11:10 to allow set-up for the Gathering of Grace service. The meeting will then reconvene next Sunday, September 17th, to continue discussion until a motion to move to a vote is approved.

He added this is a streamlined process and the intent is to vote.

Terry Schmidt moved to approve the agenda and proposed meeting rules; David Ambler seconded; motion passed unanimously.

4. Motion for Consideration.

Jonathan Becker asked for a point of order, then stated that a motion for consideration was not needed. Clay Britton agreed a motion could be made.

Devon Kim moved for approval of the proposed Plymouth Constitution and Bylaws as approved by Council on May 23<sup>rd</sup>, 2023. There shall be a separate vote by ballot for each document.

If the proposed Plymouth Constitution is approved by two-thirds of members voting, the proposed Constitution shall become effective at the Call to Order of the next Plymouth Annual Meeting and all previous Constitutions of Plymouth Church shall be revoked.

If the proposed Plymouth Bylaws are approved by a majority of members voting, the proposed Bylaws shall become effective at the Call to Order of the next Plymouth Annual Meeting and all previous Bylaws of Plymouth Church shall be revoked.

Sonia Jordan seconded the motion.

- Scott asked that ballots be distributed to members.
- Scott thanked the Bylaws Task Force for their time and effort to develop the proposed
  Constitution and Bylaws. He also expressed appreciation for the Council's unanimous approval
  following three meetings of discussion and feedback regarding the proposed revisions.

He then introduced the Bylaws Task Force members – Erika Dvorske, Elinor Schroeder, Rich Bireta, Doug Eason, Larissa Long, Liz Smith and Reverend Valerie Miller-Coleman. Some of the members offered these comments:

Erika said she felt the revisions provided a framework for faith, justice and governance.

Rich supports the council reduction from 18 to 10, as with an annual member turnover of 50% or more each year it's difficult to consider decisions strategically.

Doug is also encouraged by a smaller council membership, as goal setting is very important, and he feels we will have a stronger council. He added it probably isn't perfect, but he feels challenges can be addressed and these changes move the Church forward.

Scott said he thought it was very important to move forward. Anyone involved in recent lay leadership knows there have been bylaw challenges. He's reviewed all previous bylaws, and all had changes. This isn't a power play – he believes the congregation's voice will be strengthened.

#### 7. Member comments

John Lord said he's provided his objections in writing and is still trying to understand why changes are needed now. He'd prefer a visioning process, not an end to what is currently in place.

David Bergeron feels this is the most radical change proposed in the 150 plus years of Plymouth Church. The congregation is central to governance and now we will have smaller representation. He believes there is a disconnect between the policy book and bylaws. His concerns include no reference of boards in the bylaws; the clerk isn't a Council member and that the Sr. Pastor will be the CEO of the church.

Geraldo Sousa feels it's a coup d'etat and outrageous change.

Sue Himes said she's been on almost every board and committee over the years and that there's nothing wrong with changes. If it doesn't work, another task force can be appointed to review.

Dick Orchard feels the revisions are constructive and provide a framework for moving forward. Policies change over time. The optimal size for governance is 7-10 members. He'll vote yes.

Bob Gent is still undecided. He's concerned that the power of the church may be too concentrated and wonders if this isn't working, can it be overturned.

Genée Figuieras isn't a member, but expressed concerns based on her experience with a prior church. She thought a "pause" might be warranted.

Sarah Whitten doesn't feel it's a power grab, but it is consolidation which will place much responsibility on a small group which may result in loss of focus. She's also disappointed boards are not represented on Council. She'll vote no.

Irene Soderstrom said the bylaws have been difficult to follow and understand. They have not been functional.

Margaret Kramar – streamlining is her concern. Democracy isn't always clean and can be messy.

Megan Poindexter then called for the question. Dick Orchard seconded.

8. The meeting moved to the Mayflower Room at 11:10 for vote counting and announcement of results.

The meeting resumed at 11:25 when Scott announced the following:

- Constitution 152 voted; a 2/3 majority was required (102); 104 voted affirmatively motion passed.
- Bylaws 151 voted; a simple majority was required (76) 92 voted affirmatively motion passed.
- Adjournment

Tim Metz moved to adjourn; Devon Kim seconded; motion carried unanimously.

Meeting adjourned at 11:30.

# TREASURER'S REPORT

Plymouth finances were strong during 2023. Your incredible generosity coupled with staff fiscal responsibility led to a modest surplus of \$24,926.16. In addition to ending the year solidly 'in the black,' we were able to complete some painting and refurbishment and cover the feasibility study cost of our capital campaign using cash flow rather than endowment monies. Pledge income was higher than expected with \$20,335.64 in pledge overpayments and \$22,050 in new member pledges. Thank you!

Total pledge income for 2023 was \$860,927.97. We also received \$46,941.70 in one-time gifts for 2023, and we have experienced a consistent increase in contributions (beyond pledges) during the past two years. The annual appeal results, which far exceeded our expectations, combined with the savings we set aside when the payroll protection program monies funded payroll for eight weeks in 2020, allow us to adopt a 2024 budget that incorporates virtually all requests made by your church Boards and Committees and a 4.04% COLA for staff. We feel confident in the five-year plan we have developed to build on our financial strength and sustainability despite difficult economic times and a national decline in church giving and attendance. Plymouth consistently defies the national trend and continues to remain a strong, active, fiscally stable organization. God is at work through Plymouth Church!

While we are feeling incredibly blessed to be in a solid financial position at this time, it is imperative that we not become complacent in our giving or relaxed given the savings we have from the Payroll Protection Loan and our operating reserve. Your discipline in building and maintaining the operating reserve and your consistency in answering God's call to grow with your pledge dollars are what gives us confidence in our five-year plan. We are committed to continuing to grow alternate revenue sources in addition to working to grow our pledge income. We are confident in our ability as a congregation to generously fund our work at Plymouth. We are a people on a mission ... a vibrant, growing community with an increasing number of people committed to God's work through Plymouth Church.

As we look back on 2023, the best way to describe our thoughts about Plymouth finances, both short-term and looking forward, is gratitude. Thank you for your generous contributions of time, talent, and treasure. We are highly dependent on all three. Thank you for your active participation in the congregational budget meetings and the annual appeal. The responsibility for the Church finances belongs to all of us. Thank you for your unwavering support as we talk through complicated financial issues and continue to update and improve our dynamic longterm financial plan. The diversity of voices and thoughts as we navigate our five-year plan make us stronger. Finally, thank you for allowing us the opportunity to serve in the roles of Treasurer and Deputy Treasurer. It has truly been an honor and a pleasure.

Sally Stowits (1978): (\$10,000Cash) No restrictions on use.

**J. 0. Jones (finalized when stocks sold in 1984):** (\$4,658.24) No restrictions and to be used as Church Council directs.

Ross Hopper (1979 upon receipt of final payment on house): (\$7,691.95). Income from fund to be used as Church Council directs.

George Bradshaw (1979): (\$5,000) Per Will "Income, but no part of principal, to be used as governing body of church shall direct, except income shall not be used for ordinary operating expenses."

Mel Huxtable (1981-82): (\$7,000) "We request that the earnings from this endowment be used at the existing church property for repair, maintenance and for the church accessibility fund."

**Opal Jane Kennedy (1982-83):** (\$229,433.36) Per Will: "It is my desire that the Board of Trustees with the advice of the Board of Deacons use the income from this bequest as they may deem advantageous for the upkeep of the Church, which may include Capital Improvements."

Ellsberry-Hyre (1986): (\$5,000) Without any conditions or restrictions. Earnings at discretion of Church Council and principal by action of Congregation.

Cloyd Achning (1991): (\$20,000) To be used in accordance with provisions of the trust preserving the principal to greatest possible degree.

Carl B. Althaus (1991): (\$188,814.22) Will stated "...to establish a fund to be known as Carl B. Althaus Memorial Fund, the income but not the principal thereof, to be used for the maintenance and repair of the Church building and Church facilities. (Endowment Trust minutes of 1/14/92," To be used only for special maintenance projects, not line item maintenance. This to be liberally interpreted.)

Maude Elliott (1995): (\$11,466.35) Use of income to be determined by Church Council.

**Elizabeth Lawson (1997):** (\$20,208.78) Income to be used by the Board of Music and Fine Arts.

Mary Grant (2001): (\$75,738.98) For the use and benefit of Plymouth Congregational Church.

**Plymouth Thrift Shop (2002):** (\$12,678.15) Directed by Thrift Shop Committee through Mission/Service Board.

Rowena Puckett (2007): (\$20,502) Income to be used for building maintenance.

**Robert Frederick (2012):** (\$10,000) Income to be used for Thanksgiving service and dinner.

**Deron McGee (2015):** (\$30,000) Income to be used for the purchase of music (and supplies) for the choirs, instrumental ensembles and soloists and to provide instrumentalists and soloists for major choral works and other special occasions at Plymouth Church.

Georgia and Richard Orchard (2018): (\$25,000.00) For maintenance and repair of the church and church facilities.

**Jackie Shmalberg (2018):** (\$10,000) For music and fine arts.

Anonymous (2018): (\$92,137.00) To be used for KU campus ministry and external agencies addressing community needs of food, shelter, and health, but not for justice issues or internal church mission projects.

**Al Sellen (2018):** (\$10,488.23) No restrictions on use.

Peter Luckey Scholarship Fund (2019): (\$13,609.00) For financial support for Plymouth members and friends who seek to participate in experiences which promote justice and have transformational potential for the recipient, our congregation and/or our community.

Don & Dottie Daugherty (2023): (\$192,935.15) For the use and benefit of Plymouth Congregational Church.

**Bill Kelly:** (\$3,150) To be used for Bill Kelly Scholarship Fund.

#### Plymouth Endowment/Planned Giving Committee

In 2023 the committee approved a payment of \$74,675 for 2024 which represents 4% payout of the September 30 endowment balance averaged over the past 3 years. The funds will be distributed according to the directives of each of the endowed accounts. Plymouth Endowment funds are managed by United Church Funds which has an investment committee and portfolio managers to direct the investments. You may look at the performance in the various portfolio's at ucfunds.org under "Investments" and specifically at the UCF Balanced Fund where Plymouth's funds are invested.

The past year members of the committee contacted Plymouth members to make them aware of opportunities in Planned Giving. We also placed information in the Sunday bulletin and the monthly Rock about giving. Thank you to Elaine Schmidt, Gene Bauer, Becky Foster, Sue Himes, Don Low, Peggy Johnson, and Linda Maxey for helping to make the congregation more aware of Planned Giving.

Finally, it's important for members to think about how Planned Giving fits into the program of a nonprofit organization like a church where there are so many needs and never enough money. Most 501(c)(3) organizations raise funds in four ways: 1) Special Events, 2) Annual Gifts, 3) Major Gifts, and 4) Planned Giving. Plymouth has a number of Special Events throughout the year that are fundraisers for focused activities. Most churches support their budget through Annual Gifts in which members pledge to give throughout the year. Capital campaigns call on members to make Major Gifts to support remodeling or major replacement costs. Estate planning allows members through a Planned Giving program to continue to support the church far into the future. Opal Jane Kennedy joined the church October 15, 1913 at the age of 23. She has been supporting the mission of Plymouth each year for the past 110 years from her Annual Giving pledges while alive and her Planned Giving account which was a bequest to Plymouth in her will.
